The Summary Annual Report (SAR) is a summary of a retirement plan's financial information. The following report provides a financial snapshot for Southwest Matching Defined Contribution Retirement Plan from January 01, 2022 through December 31, 2022.

Its purpose is to summarize information on the plan's annual report for current participants, former participants with an account balance and/or beneficiaries of a participant.

You are not required to take any action, but you can request a copy of the full annual report or any individual parts of the report at any time.

The following SAR document contains information about:

- Administrative expenses that the plan paid
- The amount of benefits paid to participants and beneficiaries
- The total value of plan assets
- A pension plan's compliance with the minimum funding standards, if applicable
- Your right to receive a copy or any part of the full annual report

# Summary Annual Report

This is a summary of the annual report for Southwest Matching Defined Contribution Retirement Plan, EIN 34 1455141, for January 01, 2022 through December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Basic financial statement**

Benefits under the plan are provided by an insurance contract and a trust fund. Plan expenses were \$13,734,745. These expenses included \$422,271 in administrative expenses, \$13,297,969 in benefits paid to participants and beneficiaries and \$14,505 in other expenses. A total of 3,427 persons were participants in, or beneficiaries of, the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$188,941,095 as of December 31, 2022, compared to \$219,501,700 as of January 01, 2022. During the plan year, the plan experienced a decrease in its net assets of (\$30,560,605). This decrease includes unrealized appreciation or depreciation in the value of the plan assets; that is, the difference between the value of plan's assets at the end of the year and the value

of the assets at the beginning of the year or cost of assets acquired during the year. The plan had a total income of (\$16,825,860), including employer contributions of \$6,801,772, employee contributions of \$11,067,204, gains of \$0 from the sale of assets, and earnings from investments of (\$35,872,141).
